GOG MCF SHADE HIGHER LEVEL OBJECTIVES








Key accomplishments

- GoG MCF/SHADE
- GOG MCF SHADE has conducted 22 meetings since its inauguration in July 2021, including
 4 Plenary and 19 Working Group meetings with an average attendance of 65 attendees
- Operational procedures and information sharing tools have been introduced and operationalized
- Piracy response to incidents because of these measures have prevented hostages being taken.
- Incident information communication has been significantly accelerated to all responders
- The SHADE measures have created a transparency of events that can be closely examined now.
- Operational awareness of international and regional navies to all stakeholders is far greater because of SHADE

CAS WG Methodology Reminder


- Through the organization of **3 virtual working sessions** with the WG members:

CAS WG: Regional Force Availability



Zone E: Does not have patrol assets; coordinates with participating countries to conduct patrols. MOU for joint ops and patrols signed in 2018 by Benin, Nigeria, Togo, Niger, but not yet operational.

Nigeria: Always one asset coverage in its own TTW sectors. Assets patrol the TTW and EEZ, not beyond Has positioned small craft at river/creek entrances.

Deep Blue: 2 ships, 2 aircraft, 2 helicopters, 17 intercept craft, 16 vehicles, UAVs. Ships/interceptors have deployed in Lagos area. Intent: 90% of assets to Delta region. ROE/suspect disposition established. SATCOM, HF infrastructure nearing completion. C4I link to Navy/offshore.

CRESMAO Abidjan Zone F MMCC-CMMC MMCC-CMMC Accra Cotonou

Zone F: Noted lack of regional capability to catch/challenge pirate vessels at sea. Suggests that non-regional partners can provide assistance with that. Recent Successful cooperation with Italian Navy is proof of concept. Emphasizes YARIS effectiveness, suggests non-regional engagement with YAMS during pre-deployment.

Cameroon: Capable of high seas, EEZ, and close-toshore patrols. Covers three sectors within own TTW/EEZ.

Cote d'Ivoire: Has 4 patrol craft operating out to 60

NM. Assets underway 3-4 days weekly, 14 days monthly. 60 M patrol craft to be delivered in December, two 45 M patrol craft to arrive in late 2022, will patrol entire EEZ.

Zone D: Joint patrol model; participating nations rotate coverage of the zone with changeover monthly (one ship coverage). Cameroon and Equatorial Guinea capable of high seas deployment, Gabon does not have that capability yet.

AD WG Executive Overview



Context

 ADWG has been working to develop a maritime air coordination protocol for combating piracy and armed robbery in the GoG.

Issues/Concerns

- No standardized format for information sharing or disseminate.
- No standardized format for deconflicting airspace between partnering Nations.

Desired Outcomes

- Have a standard for all partner nations to share and disseminate information
- Ensure airspace is properly deconflicted between operating areas and partner Nations.
- Combat piracy and armed robbery in the GoG

Recommendations

- Utilize Solarta as the primary means to disseminate the ATO to regional MOCs.
- Establish Standard Operating Procedures (SOP) for MPRA deconfliction and reporting.



Next Steps



- SOLARTA to be permanently deployed to all stakeholders.
- Standing comms plan to allow mutual awareness and inter-operability between regional and international navies to be introduced for implementation.
- Legal transfer agreements in the region for piracy to be supported by SHADE.
- Air surveillance operations need to commence to support the CP response. SHADE ADWG to support this. FR Navy have offered Maritime Patrol Aircraft to test ADWG protocols for flight safety and sharing info.
- We seek greater participation by regional navies in response to incidents. Deep Blue Deployment.
- SHADE is moving to a 3 month Plenary cycle and the 5th Plenary is being hosted by Nigeria in Abuja 10th and 11th May 202
