The Seventh Governing Council Meeting of the ReCAAP ISC

Chaired by Rear Admiral Rodolfo D Isorena PCG, the *Seventh Governing Council Meeting* was held on 5-7 March 2013 in Singapore. Delegations headed by Governors / Governors' Representatives from the Contracting Parties and Partner Organisations reviewed ReCAAP ISC's works for the current and the following work year.

Chairperson welcome the United Kingdom, the 18th Contracting Party of the ReCAAP, in joining the Meeting since becoming a full-fledged member on 2 May 2012. The Council also welcome the no-

tification by Australia on 1 March 2013 of their desire to accede to the ReCAAP. The expansion of ReCAAP membership from the original 14 in November 2006 demonstrates ReCAAP's relevance and growing credibility in the international maritime community and further underscores the importance of international cooperation in combating piracy and armed robbery effectively.

The **Meeting** was pleased to note the marked improvement in the situation in Asia in 2012 of 132 incidents (123 actual and nine attempted incidents). This is the largest year-on-year decrease of 16% in the total number of incidents reported during the five year reporting period of 2008-2012. The overall improvement of the situation highlighted the effectiveness of the ReCAAP information sharing network, and operational-level cooperation and collaboration among the stakeholders.

These assistance is in addition to the secondment of staff from China, India, the Republic of Korea, Japan, the Philippines and Thailand.

The Council elected of the next Chairperson to be held by Governor for Thailand, **His Excellency Dr Pornchai Danvivathana**, and Vice -Chairperson by Governor for Bangladesh, **Mr Nasir Arif Mahmud**, with effect from 8 March 2013 for a term of two years.

Endo, the current Executive Director, to be the next Executive Director for the period of 1 April 2013 to 31 March 2016.

The Council commended the various capacity building activities. These included the successful conduct of *ReCAAP ISC Capacity Building Seminar 1/12* on 23-25 October 2012 in Singapore (where the launch and training session of the

second generation Information Network System were conducted) and *Cluster Meeting 3/12* on 23-25 July 2012 in Bangkok, Thailand, co-organised with Thailand's Ministry of Foreign Affairs and Royal Thai Navy.

The Council further commended the interregional efforts of ReCAAP ISC, in close partnership with the IMO, to share experience and expertise with the Djibouti Code of Conduct (DCoC), in particular, at the *Joint ReCAAP/ DCoC Counter Piracy Seminar and Workshop* on 3-6 December 2012 in Tokyo, Japan, funded by the Special Contribution of Japan arising from the need for closer cooperation. The event was supported by Japanese Ministry of Foreign Affairs and Japan Coast Guard, endorsed by the International Maritime Organization (IMO).

The External Participants who attended the Meeting were representatives from Malaysia, Australia, United States (for the first time), Asian Shipowners' Forum (ASF), Baltic and International Maritime Council (BIMCO), European Commission (EC), Federation of ASEAN Shipowners' Association (FASA), Singapore Shipping Association (SSA), Information Fusion Centre (IFC), International Chamber of Shipping (ICS), International Criminal Police Organization (INTERPOL), and International maritime Organization (IMO).

The next Governing Council Meeting is scheduled in the week of 3-7 March 2014.

For the first time, the Joint Social Event was held on-board *ICGS Samudra Paheredar*. ICGS Samudra Pahrerdar (CG 202) is the second Pollution Control Vessel (PCV) of its kind commissioned on 20 July 2012. She is based at Vishakapatnam (AP) under the administrative and operational command and control of the Commander Coast Guard Region (East).

The ship is equipped with state of the art pollution response equipment that include containment equipment like booms, recovery devices like skimmers and side sweeping arms and storage devices like ORO tanks and inflatable barges. The ship is capable of unhindered oil recovery operations with storage capability of 500 KL.

The ship is 94.1 M long, draws 4300 tons at

Nautical Forum 4/13

Co-organised with the ReCAAP Focal Point (Singapore) - Maritime and Port Authority of Singapore (MPA), and the Singapore Shipping Association (SSA), the fourth Event in the series was held on 10 January 2013 at the STI Auditorium of Capital Tower, Singapore.

The Forum was aimed to engage Singapore maritime community in an informal session to highlight the situation on piracy and armed robbery against ships in Asia for 2012, share/ exchange views, and solicit feedback and recommendations from the stakeholders.

Sharing on the findings of the piracy and sea robbery situation in Asia for 2012, the ReCAAP ISC reported the downward trend continued in 2012 since 2010, which is also the largest year -on-year improvement. ED-ISC credited the

stakeholders for this improvement and iterated the importance of cooperation between the governmental agencies and the industrial partners.

Other Speakers at the Forum included Captain M Segar, the Assistant Chief Executive and Mr Daniel Tan, the Executive Director

of SSA. Two Guest Speakers were Captain George Solomon, the Representative of Asian Shipowners' Forum, and Captain Maritime Haji Rozali Bin Mohd Said, Head of Maritime District Tg Sedili (East Johor) of Malaysian Maritime Enforcement Agency.
