# Piracy and Sea Robbery: Emerging Challenges ReCAAP ISC Piracy and Sea Robbery Conference 2014 8 April 2014, York Hotel, Singapore

- 1. The ReCAAP ISC, BIMCO, INTERTANKO and RSIS jointly organised the Piracy and Sea Robbery Conference 2014, on 8 April 2014 at York Hotel, Singapore the sixth event in the series that was held in conjunction with the Singapore Maritime Week.
- 2. The theme of this year's conference was *Piracy and Sea Robbery: Emerging Challenges*. The aim of this Conference was to provide a platform for all to be apprised of the latest trends and assessments of piracy and sea robbery situation in Asia in 2014 that included sharing of case studies for best management practices and lessons learned, and to express views on the current situation and propose possible solutions to address the challenges. The theme is very timely given the expansion of membership of ReCAAP, and the discussion on the "Future of the ReCAAP ISC" as an agenda item of the ReCAAP ISC Governing Council Meeting.
- 3. At the opening remarks delivered by Ambassador Dr Pornchai Danvivathana, Governor (Thailand), also the Chairperson of the ReCAAP ISC Governing Council, noting the emergence of certain patterns and trends, and modus operandi of pirates and robbers, he emphasised the need for timely and accurate situation awareness. This would empower the authorities and shipping industry to derive appropriate counter-measures to tackle the emerging threats and challenges at sea. He added that although the overall improvement of piracy and sea robbery situation in Asia has continued in 2014 first quarter since 2010, there is however no room for complacency.
- 4. For the first time, the Conference offered two interactive panel discussions with distinguished and renounced panelists who were experts in their own fields. These panel discussions moderated by Dr Euan Graham of RSIS focused on evolving challenges and converging solutions respectively. Audiences participated actively at both discussions posing numerous thought-provoking questions based on different perspectives.

5. In the closing remarks delivered by Mr Yoshihisa Endo, the Executive Director of the ReCAAP ISC, he appreciated the turn-out rate of 170 participants. These included Heads of Diplomatic mission of ReCAAP's Contracting Parties, government agencies from Malaysia and Singapore, ASF<sup>1</sup>, distinguished national shipping associations of Indonesia, Malaysia and Singapore (INSA<sup>2</sup>, MASA<sup>3</sup> and SSA<sup>4</sup>), higher learning institutes (CIL<sup>5</sup> and SMA<sup>6</sup>), research institutes (KAS<sup>7</sup> and NAMARIN<sup>8</sup>), other stakeholders and like-minded individuals. He reiterated the paramount importance of cooperation among all stakeholders, and the essentiality of information-sharing in supporting ReCAAP ISC's continued development as the foremost organisation in promoting and enhancing regional cooperation against piracy and armed robbery in Asia.

# **FACT SHEET**

About the Regional Cooperation Agreement on Combating Piracy and Armed Robbery against Ships in Asia (ReCAAP), and the ReCAAP Information Sharing Centre (ISC)

The Regional Cooperation Agreement on Combating Piracy and Armed Robbery against Ships in Asia (ReCAAP) is the first regional government-to-government agreement to promote and enhance cooperation against piracy and armed robbery in Asia. It was finalised on 11 November 2004 and entered into force on 4 September 2006. To date, 19 States have become Contracting Parties to ReCAAP.

The nineteen Contracting Parties to ReCAAP are Australia, the People's Republic of Bangladesh, Brunei Darussalam, the Kingdom of Cambodia, the People's Republic of China, the Kingdom of Denmark, the Republic of India, Japan, the Republic of Korea, the Lao People's Democratic Republic, the Republic of the Union of Myanmar, the Kingdom of the Netherlands, the Kingdom of Norway, the Republic of the Philippines, the Republic of Singapore, the Democratic Socialist Republic of Sri Lanka, the Kingdom of Thailand, the United Kingdom and the Socialist Republic of Viet Nam.

The ReCAAP Information Sharing Centre (ReCAAP ISC) was established under the Agreement, and was officially launched in Singapore on 29 November 2006. It was formally recognised as an international organisation on 30 January 2007.

The roles of the ReCAAP ISC are to:

- serve as a platform for information exchange with the ReCAAP Focal Points via the Information Network System (IFN); facilitate communications and information exchange among participating governments to improve incident response by member countries; analyse and provide accurate statistics of the piracy and armed robbery incidents to foster better understanding of the situation in Asia;
- facilitate capacity building efforts that help improve the capability of member countries in combating piracy and armed robbery in the region; and
- cooperate with organizations and like-minded parties on joint exercises, information sharing, capacity building programme, or other forms of cooperation, as appropriate, and agreed upon among the Contracting Parties.

The ReCAAP ISC facilitates exchange of information among the ReCAAP Focal Points through a secure web-based Information Network System (IFN). Through this network, the ReCAAP Focal Points are linked to each other as well as the ReCAAP ISC on a 24/7 basis, and are able to facilitate appropriate responses to incident. The agency receiving the incident report will manage the incident in accordance to its national policies and response procedures, and provide assistance to the victim ship where possible. The agency will in turn, inform their ReCAAP Focal Point which will submit an incident report to the ReCAAP ISC and its neighbouring Focal Points.
